ePublication Policy — E-Book Publication, Copyright & Access

Effective from the date of issue

1. Overview

Rudra Academic Press offers a complete end-to-end e-book publication service for edited volumes and authored works. This policy document outlines the publication support provided, applicable charges, royalty structure, book pricing terms, copyright framework, access and self-archiving terms, and the plagiarism standard that governs every e-book published under the Rudra Academic Press imprint.

2. Publication Support Provided

- International Standard Book Number (ISBN) allotment for every published e-book.
- Digital Object Identifier (DOI) assignment for the e-book and, where applicable, individual chapters.
- Professional editorial formatting, cover design, and digital publication of the final e-book.

3. Publication Charges

Publication charges are structured according to the number of chapters and the maximum permissible page count per chapter, as detailed below:

Category	Chapter Range	Pages per Chapter	Publication Charges
Plan A	10 – 12 Chapters	Maximum 10 – 12 pages per chapter	Rs. 8,500/-
Plan B	15 – 18 Chapters	Maximum 13 – 15 pages per chapter	Rs. 12,500/-

Note: Chapters exceeding the specified maximum page limit may attract additional charges as communicated by the editorial team prior to final processing.

4. Royalty Benefits

Royalty on book sales is shared between the Author(s)/Editor(s) and Rudra Academic Press in the following proportion:

Author / Editor Category	Author/Editor Share	Publisher Share
Indian Author / Editor	70%	30%
Foreign Author / Editor	50%	50%

The royalty classification (Indian / Foreign) is determined by the nationality and primary residence of the corresponding Author/Editor at the time of submission.

5. Book Pricing

The final retail price of each e-book shall be decided by Rudra Academic Press in consultation with, and with the consent of, the Author(s)/Editor(s). Pricing will take into account the number of chapters, total page count, production quality, and prevailing market standards for similar academic publications.

6. Copyright Policy

This Copyright Policy governs the ownership, transfer, and use of copyright for all e-books, edited volumes, and individual chapters published by Rudra Academic Press ("the Publisher"). It applies to all Authors, Editors, and Contributors ("the Author(s)") who submit content for publication, and forms an integral part of the publication agreement executed at the time of acceptance.

6.1 Copyright Ownership and Transfer

- Upon acceptance of a chapter or manuscript for publication, the Author(s) shall assign copyright of the final, published version of the work to Rudra Academic Press through a signed Copyright Transfer Agreement (CTA), unless an alternate licensing arrangement is agreed in writing.
- Where a work is published under the Open Access Upgrade (see Section 7.2), the Author(s) may instead retain copyright and grant the Publisher an exclusive license to publish, distribute, and commercially exploit the work under the terms agreed at submission.
- Copyright transfer/license takes effect only upon final acceptance of the manuscript and receipt of applicable publication charges.
- For edited volumes, the Editor(s) hold responsibility for ensuring that each contributing chapter Author has executed the requisite copyright agreement prior to inclusion in the volume.

6.2 Rights Retained by the Author(s)

Notwithstanding the transfer of copyright, Author(s) retain the following rights:

- The right to be identified as the Author/Editor of the work (moral rights).
- The right to reuse their own chapter content, in whole or in part, in a future thesis, dissertation, or compilation, provided the original publication is duly acknowledged and cited.
- The right to share the final published version for personal, academic, and non-commercial purposes, in accordance with the Access and Self-Archiving Policy set out in Section 7.
- The right to use figures, tables, and short excerpts from their own chapter in future academic presentations or teaching materials, with appropriate citation.

6.3 Rights Granted to Rudra Academic Press

Upon copyright transfer or license, the Publisher is granted the exclusive right to:

- Reproduce, publish, distribute, and sell the e-book in digital and, where applicable, print formats, worldwide, through all current and future media.
- Assign ISBN and DOI identifiers to the work and register it with relevant indexing, archiving, and cataloguing bodies.

- License third parties (e.g., aggregators, libraries, and academic databases) to host, distribute, or provide access to the work.
- Take necessary legal action against unauthorized reproduction, distribution, or infringement of the published work.

6.4 Third-Party Content and Permissions

- Author(s) are solely responsible for obtaining written permission for the use of any third-party copyrighted material (images, tables, data, extended quotations, etc.) included in their chapter, prior to submission.
- Proof of permission must be submitted along with the final manuscript. The Publisher accepts no liability for uncleared third-party content.
- Any material reproduced from another source must be clearly credited to the original copyright holder within the chapter.

6.5 Originality and Author Warranties

By submitting a manuscript, the Author(s) warrant that:

- The work is original, has not been published elsewhere in whole or substantial part, and is not under consideration for publication elsewhere.
- The work does not infringe upon the copyright, privacy, or other rights of any third party.
- The similarity/plagiarism index of each chapter is below 15%, as verified by the Publisher's plagiarism-detection process.
- All named Co-Author(s)/Contributors have consented to the submission and to the terms of this Copyright Policy.
- The Author(s) hold full authority to enter into the copyright agreement and to grant the rights described herein.

6.6 Indemnification

The Author(s) agree to indemnify and hold harmless Rudra Academic Press against any claims, damages, costs, or liabilities arising from a breach of the warranties set out in Section 6.5, including claims of plagiarism, defamation, or infringement of third-party rights.

6.7 Duration and Territory

Unless otherwise specified in the publication agreement, the copyright transfer or exclusive license granted to Rudra Academic Press remains valid for the full legal term of copyright protection and applies worldwide, across all languages and formats, including future technologies of reproduction and distribution.

6.8 Amendments

Rudra Academic Press reserves the right to revise this Copyright Policy from time to time. The version of the policy in effect at the time of manuscript acceptance shall govern that particular publication.

7. Access and Self-Archiving Policy

This section sets out the access model, and the self-archiving rights of Authors/Editors, for e-books published by Rudra Academic Press. It is intended to give Authors/Editors clarity on how and where they may share their published work, while protecting the commercial viability of the Publisher's paid e-book download service.

7.1 Access Model

- E-books published by Rudra Academic Press are made available under a Closed Access (Paid Access) model. Full-text download of the published e-book is a commercial product and is available to readers/institutions only upon purchase.
- The publication charge collected from Author(s)/Editor(s) at the time of submission (Section 3) covers editorial processing, formatting, cover design, ISBN and DOI assignment, indexing, and hosting of the work. It does not constitute an Open Access fee and does not entitle the Author(s)/Editor(s), or any third party, to free public distribution of the final published e-book.
- Revenue generated from e-book sales is shared with the Author(s)/Editor(s) as per the Royalty Benefits set out in Section 4.

7.2 Optional Open Access Upgrade

Author(s)/Editor(s) who wish to make their chapter or e-book freely downloadable to the public may opt into the Publisher's Open Access Upgrade, available for an additional fee, payable at the time of submission or prior to final publication.

- Where the Open Access Upgrade is purchased, the specific chapter or e-book will be published under a designated open license (e.g., Creative Commons), and the applicable license terms will be displayed on its copyright page.
- Chapters/e-books for which the Open Access Upgrade has not been purchased remain under the standard Closed Access model described in Section 7.1.
- Within a single edited volume, some chapters may be Open Access and others Closed Access, depending on individual Author/Editor choice; each chapter's access status will be clearly indicated.

7.3 Self-Archiving Rights of Authors/Editors

For works published under the standard Closed Access model, the following self-archiving permissions apply:

Abstract, Table of Contents, Chapter/Author listing	Permitted, anytime	Permitted, anytime
Author's own pre-print (pre-formatting, pre-typesetting manuscript)	Permitted, anytime	Not permitted
Final typeset chapter/e-book (Publisher's formatted PDF)	Personal, non-public use only (e.g., CV, thesis appendix)	Not permitted

Author(s)/Editor(s) who have purchased the Open Access Upgrade for their chapter or e-book (Section 7.2) may self-archive and publicly share the final typeset version of that specific content without restriction, subject to the open license terms applied.

7.4 Restrictions

- Author(s)/Editor(s) must not upload the Publisher's final typeset PDF of a Closed Access chapter or e-book to any public repository, academic networking site (e.g., ResearchGate, Academia.edu), file-sharing platform, or personal/institutional website in a manner that allows free public download.
- Author(s)/Editor(s) must not circulate the final typeset version to third parties for further redistribution or resale.
- Any breach of this policy may be treated as a breach of the Copyright Policy (Section 6) and the publication agreement, and the Publisher reserves the right to request removal of unauthorized copies.

7.5 Institutional and Library Access

Libraries, universities, and institutions seeking full-text access to a Closed Access e-book for their members or students may do so through institutional purchase or a site license arranged directly with Rudra Academic Press, rather than through individual free downloads.

7.6 Amendments

Rudra Academic Press reserves the right to revise this Access and Self-Archiving Policy from time to time. The version in effect at the time of manuscript acceptance shall govern that particular publication.

8. Plagiarism Policy

Rudra Academic Press maintains a strict originality standard for all submitted content. Each chapter submitted for publication must have a plagiarism/similarity index below 15%, as verified through a recognized plagiarism-detection tool. Chapters exceeding this threshold will be returned to the Author(s)/Editor(s) for revision prior to acceptance.
